# RGM26-001 TAILINGS CONSTRUCTION 2026 THROUGH 2027

# 1. Works Information

### 1.1. Introduction

The engineering and subsequent construction of the Tailings Storage Facility (TSF) is a fundamental annual project for ensuring the continuation of operations at Rosebel Gold Mines (RGM). The TSF comprises 14 dams that make up the current facility (TSF1 and TSF2), with another 3 dams planned with the implementation of the Tailings 3 Expansion (TSF3), see figure 1. The TSF represents a confined facility in which tailings are deposited in accordance with mining and subsequent mill production. Construction throughout 2025, already commenced primarily of the TSF3 expansion project, with detail progressing on 3 dams, which are North West Dam, South West Dam, and SD 14.

This document provides information for the tender invitation for a 2-year construction campaign through 2026 and 2027. The timeline for construction works is in accordance with the calendar years 01 January 2026 through 31st December 2027.

## 1.2. Location

Rosebel Gold Mines N.V. (RGM) is located in the Brokopondo district in northeastern Suriname. RGM lies approximately 85 kilometers (km) south of Paramaribo. The mining concession covers 170 square kilometers (km2), with the Suriname River to the east, the Saramacca River to the west, and the Brokopondo reservoir to the south (see Figure 2).

# 1.3. General work background and constraints

The climate is classified as tropical warm, resulting in four seasons:

- Early February to late April, a short dry season;
- Late April to mid-August, a long rainy season;
- Mid-August to early December, a long dry season; and,
- Early December to late February, a short rainy season

RGM lies in a tropical climate with an average annual precipitation of 2284 millimeters (mm) and an average annual potential evaporation of 1513 mm.

Historically, RGM has completed construction throughout the drier periods of the year (usually July to December), but this is dependent on construction requirements and frequently includes January to March. For this proposal, contractors should take into account the potential for wet seasons.

The following working constraints should be considered for the proposal;

- 1. Estimations should include provision of onsite offices and workshop (if not already in place), a location of which will be provided by RGM. All mobilization and set-up costs (to include services and utilities) will be the responsibility of the contractor, and therefore an allowance should be made in the bill of quantities for preliminary costs.
- 2. RGM will cover all board (food and accommodation) for contractor personnel, unless there is a requirement for the personnel to be located off-site. In relation to the latter, a cost should be provided in the bill of quantities (BOQ).
- 3. RGM will cover all fuel for vehicles that are required for the TSF construction project.

#### Access

Site entry will be carried out in accordance with RGM standards, and RGM will complete necessary inductions. All personnel working at Rosebel Gold Mines (RGM) will be required to provide the standard entry requirements (medical, police clearance, etc). Further details will be provided as

required by the HR department. Only working vehicles (company-assigned) are permitted on-site. All Personal vehicles will have to be parked outside the main gate in a designated car park.

The bidder shall submit two documents clearly showing heading "TSF Construction 2026-2027- Technical Offer" and "TSF Construction 2026-2027 - Financial Offer".

- List of all equipment and hourly rental rates that will be utilized on this project

#### 1.10. Evaluation Criteria

Selection criteria are based on a 100 point evaluation.

#### 1.11. Changes to Proposals

The proposal submitted is irrevocable by the bidder. Bidders will not be permitted to alter their proposals once they have been submitted.

#### 1.12. Proposal Validity

Proposals are required to be valid for (60) days.

#### 1.13. Liability for Costs, Expenses and Information

Rosebel will not be liable for any costs or expenses incurred by any bidder including, without limitation, any expenses incurred in the preparation and submissions of the proposal.

#### 1.14. Alternative Proposals

Bidders are encouraged to propose alternative proposals for consideration by Rosebel. Alternate proposals that the bidder feels may offer additional advantages to Rosebel must be submitted at the same time as the main proposal. They should be prioritised and the benefits of each alternative proposal must be clearly stated.

Rosebel reserve the right to accept or reject proposed alternatives as it sees fit, and to claim for itself the financial benefit of a substitution. Rejection by Rosebel of the proposed alternatives is final. Rosebel is not obligated to give any reason for its rejection of alternative proposals.

#### 1.15. Right to Clarify and Negotiate

Rosebel without liability, cost, or penalty may in its sole discretion and at any time after proposal submission may seek clarification from the bidder or negotiate items relating to the proposal.
